**PREAMBLE :**

KNOW ALL MEN BY THESE PRESENTS THAT, Vihang Garg son of Sh. AND WHEREAS THE SETTLER has on execution of these presents handed over to the Trustees the said sum of **Rs.11,000.00 (Rupees Eleven thousand only)** in cash and the Trustees hereby acknowledge to have received the same to hold on Trust.

NOW KNOW WE ALL AND THESE PRESENTS witness that the said sum of **Rs.11,000.00 (Rupees Eleven thousand only)** be held by these presents upon the Trust for the purposes and subject to the powers, provisions and conditions hereinafter mentioned:

**NAME:**

1. The Trust hereby created shall be known as "GARVIT VITEE EDUCATIONAL TRUST"

**OFFICE:**


2. The Registered office of the Trust shall be situated in the state of Uttar Pradesh, Ghaziabad and at present located at Hitech World School, Sunecity(Dasna), Ghaziabad.

**TRUST FUND:**

3. That the Trust Fund shall initially consist of a sum of Rs.11,000.00(Rupees Eleven thousand only) which has been contributed by the SETTLER of the Trust and this fund shall henceforth vest in the Trust and the Trustees shall hold this in trust and utilize the said sum and income thereof for the objects of the Trust as provided herein, in this Deed of Trust.
4. That the Trust Fund shall further consist of any offerings, contributions, donations, gifts, and bequests etc. made to the Trust and Trustees shall hold the said fund and income there from in Trust to be utilized for the objects of the Trust.

**OBJECTS OF THE TRUST:**

5. This Trust is created for carrying out the following objects of Public Charity within India and for the benefit of the Members of General Public without any distinction of caste, religion, colour, creed, sect, sex, or any other natural or man-made differences:-
  - i) To open ten-plus-two school, primary school, educational and vocational colleges / institutions to impart education and spread literacy.
  - ii) To open Medical, Engineering and Technical Colleges and Research institute to spread advance science and Technical Knowledge and Universities.



- iii) To help, aid, assist undertake, organize, establish and maintain schools, Colleges Institutions or Centers for imparting general professional, vocational, industrial, technical, physical, intellectual and moral education and to promote the advancement of education art, science and health and to assist and provide financial assistance for any other cause of general public utility not involving any activity for profit.
- iv) To establish hospitals, clinics, sanatorium and convalescent homes for the practice of medicine with upto date facilities and to maintain or give grants to any dispensary, hospital, maternity home, woman's hospital, sanatorium, convalescent homes and child welfare centres or to establish, provide and meet cost for beds in any hospital or sanatorium and arrange for the maintenance thereof for the benefit of the general public.
- v) To maintain contribute or to give aid to any Engineering's, Medical, Educational or Social Institutions or to any charitable institution with a philanthropic purpose which may be in general interest of the poor and the destitute and to do all such acts and things with the object of giving relief to the poor.
- vi) To found, assist, support, establish and maintain libraries and reading rooms, and to establish and maintain boarding houses and hostels and assist such institution.
- vii) To provide for endowments, stipends, scholarships and other allowances to the poor, deserving or needy students and or the promotion and encouragement of all types of education.
- viii) To build a community Hall where religious discussions, Bhajans, spiritual education, cultural activities can be conducted.
- ix) To educate the people of the value of Indian Culture and Civilization as an order of life based on service to humanity, truthfulness, non-violence, kindness and cultured outlook.
- x) To establish and maintain Dharamshalas, Rest Houses or any other such charitable institutions for the benefit or the society at any suitable place of places.
- xi) To maintain orphanages and homes for old, aged, anfeables disabled, infirm, blind, handicapped, and destitute persons, neglected and needy women and children and to provide them education and vocational and other training etc. to enable them to become self-reliant and to render such assistance to any such existing institution(s).


No property is being transferred through this Deed.



- xii) To do all other such acts and things which are incidental or conductive to the attainment of the objects specified herein above and for promoting the general welfare and well being of the society and uplifting the social educational cultural or economic condition of the masses.

PROVIDED that if any one or more of the purposes of objects specified in this clause are held not to the purpose of object of a public charitable nature, the Trustees shall not carry out such purpose or objects and the validity of the Trust created by these presents as a trust for public Charitable object or purpose shall not be effected in any manner.

6. The Trust shall in furtherance of all or any of its OBJECTS shall
- 6.1) Receive and accept contributions, subscription, offerings, donations, grants, presents, gifts, and other assistance in cash or in kind from any organization, institution, trust Society, individuals and other person from India and overseas.
  - 6.2) Construct, acquire, renovate, furnish, demolish or alter any building(s), which may be necessary or expedient for the attainment of the said objects.
  - 6.3) Acquire, construct, renovate, furnish and maintain Homes for Old aged and places of meditation and spiritual activity.
  - 6.4) Purchase, take on lease, exchange, hire accept as a gift or otherwise, acquire land and/or buildings or deal in any movable or immovable property or rights therein or privileges attached thereto which may be necessary or expedient for the attainment of its objects.
  - 6.5) Publish books, journals, literature and newspapers reprint scriptures.
  - 6.6) Manage the trust property, collect and recover rents, interest and other income thereof and to pay the expenses of managing the Trust property and all other outgoings, if any.
  - 6.7) Pay or utilize the balance of such rents and interests or income of the Trust property (hereinafter called 'the net income of the Trust Property') and the accumulations thereof as well as the corpus of the Trust property in pursuit of the objects of the Trust.
  - 6.8) Sell lease mortgage, charge, surrender, let on hire, exchange, dispose - off otherwise transfer for the consideration, all or any portion of the property, rights and assets of the Trust.
  - 6.9) To invest, deposit and otherwise deal with the money of the Trust not immediately required in such manner as may be determined from time to time.




- 6.10) To charge Tuition fees and otherwise recoup itself for the outlay and expenses incurred in the upkeep and maintenance of schools, colleges and/or Institutions established or about to be established under this deed.
- 6.11) To borrow, raise or secure the payment of money or to receive money as loan for the objects of the Trust from any person firm, bank, financial institution or company whether with or without any security of the property of the Trust.
- 6.12) To enter into contracts and arrangements of all kinds.
- 6.13) To institute, conduct, intervanee in or compromise, suits and other legal proceedings of any kind by and against the trust or its officers.
- 6.14) To do all such other things as may be deemed incidental or conducive to the attainment of objects of the trust herein above mentioned.

**FIRST TRUSTEES:**

7. The following shall be the First Trustees of the Trust:

The first trustee shall hold office during their life time, unless any of them resigns of his/her own will. In case of death of any Trustee his/her chief legal heir will be taken as a trustee in his/her place subject to the approval of Board of Trustees in their meeting. However, if Board of Trustees do not accord their consent for the appointment of chief legal heir of deceased Trustee, as Trustee in his/her place, any other family member as opted by the family of deceased Trustee, shall be appointed as Trustee in place so such deceased Trustee. Likewise if any Trustee during his/her life time wants that any of his/her family members be appointed as trustee in his/her place, such appointment can be made subject to the approval of Board of Trustees in their meeting.

8. Any person/or persons who directly or indirectly helps the trust in collecting the funds for the trust or helps in its smooth running or are expert in their fields and committed to the upliftment of the humanity, the Board of Trustees may co-opt such person/s for the benefit of the Trust.

**RETIREMENT:**

9. If a Trustee for the time being, resigns of his/her own free will or becomes an insolvent or of unsound mind or is held guilty of any offense involving moral turpitude he/she shall be deemed to have retired, subject to the confirmation of the Board of Trustees in their meeting.

**BOARD OF TRUSTEES :**

10. The management of the trust shall be in the hands of Board of Trustees and all the Trustees unless otherwise decide, shall constitutes the Board of Trustees of the Trust. The number of Trustees at any time shall be minimum Five and maximum Eleven.

**OFFICE BEARERS:**

11. The Board of Trustees shall constitutes of following office bearers:-

1. Chairman
2. Secretary
3. Treasurer

12. The terms of the office bearers of the Board of Trustees, except Chairman to the extent specified under para 12 here above, shall be of five years or such extended period till the next annual general meeting is held there after. Election for the office bearers of the Trust shall be amongst trustees themselves and they shall be elected as per Election Rules framed by the trustees from time to time.

In the event of any vacancy arising on account of resignation or any other cause, of any office bearer, the Board of Trustees shall elect the new office Bearer in his place from amongst themselves.

**MANAGEMENT OF THE TRUST**

**FUNCTION OF THE CHAIRMAN:**

13. The Chairman shall preside over all the meetings of the Board of Trustees. The business of the Trust shall be conducted under his directions and guidance.

**FUNCTIONS OF SECRETARY :**

14. The Secretary shall issue notice for all meetings of the Board of trustees, in consultation with or under the directions of the Chairman and/or the Board of trustees. He shall maintain records and minutes of the proceedings of the meetings. He shall co-ordinate the activities of various committees and/or institutions being run under the control of the Trust and shall ensure the implementation of the decisions of the Board of Trustees. He shall conduct the day to-day business of the Trust.

15. In the absence of Chairman, the secretary shall preside over all the meetings of the Board of Trustees. He shall do all such jobs and duties as assigned to him by the Chairman, and/or by Board of Trustees.

**FUNCTIONS OF THE TREASURER:**

16. The Treasurer shall be responsible for supervising, controlling and maintaining accounts of the Trust fund/properties and perform such financial duties as may be entrusted to him by the Chairman or Board of Trustees from time to time.

The Treasurer shall issue notice for all meetings of the Board of trustees.

**POWERS AND RIGHTS OF TRUSTEES**

**ACCEPT DONATIONS:**

17. The Board of Trustees shall have the power to receive and accept offerings and donations in the shape of cash or kind, securities/shares and debentures of joint stock companies, movable or immovable property of free hold or any other kind or such terms and conditions as they may think fit, not being inconsistent with these presents of the Trust hereby established.

**BORROW MONEY :**

18. To borrow moneys either on the security of any property comprised in the Trust Fund otherwise, for all or any of the purposes of these presents and it shall be lawfull for the Trustees to make such borrowings on payments of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.

**HIRE PROPERTY :**

19. The Board of trustees may hire, take on loan or lease any immovable or movable property for all or any of the purposes of the said trust, at such rents and on such terms and conditions and for such period of periods and with or without option for renewal option for renewal as they may think fit, for carrying out generally its objects or any of them.

**PURCHASE PROPERTY :**

20. The Board of Trustees may purchase movable and immovable properties for the Trust demolishand/or rebuild immovable property of the Trust and/or make additions, alterations and improvements thereto and/or develop the same in such a manner as the Trustees in their absolute discretion many think fit.

**SPEND MONEY :**

21. The Trustees shall have the power to spend such money out of the corpus of the trust or out of the sale proceeds of any property or part thereof or any other income of the Trust or out of the borrowed funds and appropriate such money or part thereof for laying out, erecting, renovating, furnishing and maintaining such buildings for the schools, Colleges, Hospitals etc. and places



of meditation and spiritual centres and for any of the purposes of the Trust administration and day to day expenses.

**LET OUT PROPERTY :**

22. The Board of Trustees may let/lease out any movable/immovable property of the Trust in their absolute discretion in such manner as the Trustees may think proper, in the interest of Trust.

**HOLD PROPERTY IN TRUST:**

23. All properties that may be acquired by the Trust shall be held by the Board of Trustees in trust and the same together with income therefrom, if any, shall always be utilised for the purposes and objects for the Trust. It shall, however, be lawful for the Trustees to accumulate the income of the Trust for utilization at a later stage.

**BANK ACCOUNT:**

24. The Trustees shall have the power to open Account/Accounts in the name of the Trust, Schools or Institutions run/conducted by the Trust with any one or more Scheduled Banks or with any Financial Institutions as may be decided by them.

The Bank account shall be operated under the signature of Chairman, Secretary or treasurer or under any two.

**INVEST MONEY :**

25. It shall be lawful for the Board of Trustees to invest so much of the trust property as may consist of money not immediately required for any of the purposes of the trust in accordance with provision of Income Tax Act 1961, including deposits in Banks mutual Funds, various investment Schemes of Unit Trust of India and other approved Government Securities and properties for earning interest/rents to carry on the object of the Trust.

**RE-IMBURSE EXPENSES :**


26. The Trustees will not be entitled to receive any remuneration but they may reimburse themselves out of the Trust funds all expenses legitimately incurred by them in the execution of and for the purposes of the Trust.

**SELL/EXCHANGE PROPERTY :**

27. It shall be lawful for the Trustees at any time to exchange sell/dispose off or transfer any immovable property of the Trust or Part thereof except places of worship for which the consent in writing of all the Trustees for the time being shall be essential.

**PROPERTY TO BE ADMINISTERED AS PER PROVISIONS :**

28. The Trust's assets shall be administered, controlled, spend and managed in accordance with the provisions contained in these presents and Rules and Regulations in Vogue.



**MANAGER PRUDENTLY :**

29. The Trustees shall manage the subject matter of the Trust prudently and in such manner as they would do in case of their own affairs.

**FORMATION OF SOCIETY :**

30. The Trustees may incorporate a society under the Societies Registration Act, for carrying out the object of this Trust. The Society so formed shall not be entitled to incur any liability or obligation on behalf of the Trust. Society shall merely carry on the object of the Trust with such funds as may be made available to it by the Trust. The Society shall render the accounts to the Trust.

**COMPROMISE OR REFER CLAIMS FOR ARBITRATION :**

31. The Board of Trustees may compromise and compound claims of the trust and may refer any difference or dispute to arbitration.

**TRUSTEES RESPONSIBLE FOR OWN ACTS ONLY :**

32. The Trustees shall be responsible and answerable for their own respective acts, omissions, neglects and defaults and not for others, for such moneys as they shall respectively actually receive on behalf of and for the purposes of the Trust.

**PATRONS :**

33. It shall be lawful for the Trustees to appoint one or more patrons of the Trust.

**COMMITTEES :**

34. a) The Board of Trustees shall have the Powers to appoint various committees/sub-committees and frame Rules and regulations therefor from time to time and may alter or rescind any one or more of them.  
b) A Trustee alone shall be entitled to become the Chairman of such committees/sub-committees.  
c) The Chairman and the Secretary/ Treasurer of the Trust shall be ex-officio members of all such committees/sub-committees.

**DELEGATION OF POWERS :**


35. The Trustees for the time being may delegate all or any of their powers to any Trustee/s and / or the office Bearers of the trust jointly or severally as may be deemed necessary from time to time.

**APPOINT STAFF :**

36. The Trustees shall have the power to appoint such staff on such terms and remuneration as they may consider necessary and expedient and may terminate or suspend their services at any time, at their discretion.

**APPOINT ATTORNEY :**

37. The Trustee may appoint constitute attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested to them and from



time to time remove such attorneys or agents and to appoint other or others in his/her or their place.

**OTHERS:**

38. The Trustees are entitled to carry all such acts, deeds and things which they deem are incidental or conducive to the attainment of the objects of the trust as specified hereinabove.

**ACCOUNTS AND AUDIT**

39. The Trustees shall cause regular account books to be maintained for the incoming and outgoing on trust account at the close of 31<sup>st</sup> March of every year.
40. The Annual Accounts of the Trust shall be got audited from an approved Chartered Accountant as may be appointed by the Board of Trustees.

**MEETINGS**

**ANNUAL GENERAL MEETINGS :**

41. The Board of trustees shall hold atleast four meetings in each year, one of which shall be called "Annual General Meeting" wherein accounts shall be approved, Auditors will be appointed and elections/co-option of the office bearer of Board of Trustee etc. if any due, shall also be held.
42. The Chairman/ Secretary/ Treasurer, however may call a meeting of the Trustees at any time, if considered necessary.

**NOTICE:**

43. The meeting shall be called by giving Seven days notice specifying time, date and venue of such meeting, as may be decided. An Emergent Meeting may, however, be called at a shorter notice.

**REQUISITIONED MEETING :**


44. The Chairman/ Secretary/ shall call a meeting of the trustees of the trustees on the requisition made to either of them in writing by any two third of the trustees for the time being specifying the purpose for which such meeting is desired to be held. In the event no meeting being called and held within twenty-one days from the receipt by them of such requisition, the requisitionists may themselves a meeting.

**QUORUM:**

45. Six Trustees or three-fifth to total strength of Trustees, whichever is higher, personally present, shall form quorum of a meeting.

**ADJOURNED MEETING :**

46. 1. If at a regular meeting no quorum is present within half an hour of the time fixed for the meeting, the meeting shall stand adjourned to the next day to be held on the same time and the same place. At such adjourned meeting the quorum shall be four trustees personally present.



2. In the case of a requisitioned meeting, if the quorum is not present within half an hour from the time fixed for such meeting, the same shall stand cancelled automatically.

**TO PRESIDE MEETINGS :**

47. The meeting of the trustees shall be presided by the Chairman, in his/her absence, by Secretary.

**DECISIONS OF BAORD OF TRUSTEES :**

48. All matters shall be decided by the Board of Trustees at a meeting by majority of two third of total number of Trustees.

**RESOLUTION BY CIRCULATION :**

49. Any resolution passed by circulation must have the consent of at least two third of the total number of the Trustees for the time being.

**GENERAL ACTS DONE IN GOOD FAITH :**

50. The Board of Trustees and many committee/sub-committing shall in good faith, carry out the purposes or functions which the exigencies of the situation may demand or require and any act, deeds or things so done by the Trustee shall not be called in question.

**VALIDITY OF ACTS :**

51. All the acts done by any meeting of the Board of Trustees or a Committee/Sub-Committee, so appointed by the Board of trustees in good faith, shall not with standing that it may afterwards be discovered that there existed a vacancy/vacancies or that there was some defect in the appointment of any one or more of such Trustees or any of them were disqualified, be as valid as if every such Trustee had duly appointed and was qualified to be a trustee.

**TRUST IRREVOCABLE :**

52. The Trust hereby declared and created shall be and remain irrevocable for all times. However, by a unanimous decision of all the Trustees, the same may be dissolved and merged into/amalgamate with any other Trust or Society etc. having interalia the same or similar objects.

**POWER TO MODIFY RULES & REGULATIONS :**

53. The Trustees shall have the power by majority of not less than two third of the total numbers of Trustees to frame, add, alter, modify repeal or substitute any provision of this Trust Decd or any Rules and Regulations made there under, provided, however, that such rules, regulations and provisions shall offend the Objects and purposes of these presents or be inconsistent therewith.



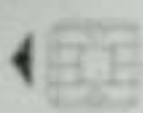
